

Dear Mr Wright

I am writing to you in relation to my Register of Pecuniary Interests.

For approximately 11 years, I have had a health insurance policy with Medical Benefits Australia (MBF).

This, of course, has not been declared on my House of Representative's Pecuniary Interests Register, as it has not been a pecuniary interest simply an insurance policy.

Recently, however, MBF has proposed its demutualisation and amalgamation with BUPA. This involves a payment to MBF members.

Accordingly, there is potential that my MBF membership could now be perceived as a pecuniary interest, I wish to declare my insurance policy in the interest at full disclosure.

Furthermore, the Parliament will this week consider the Tax Laws Amendment (2008 Measures No.4) Bill 2008. This Bill provides relief from capital gains tax (CGT) to health insurance policyholders when their insurer converts from being a not for profit to a for profit insurer by demutualising. These amendments will ensure that any capital gains or losses arising to policyholders under their insurer's demutualisation are disregarded – whether they receive shares or cash payout – and will provide policyholders with a market value cost base for shares they receive in the demutualised entity.
