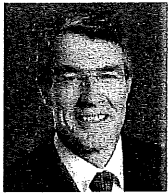
I write to advise you of the following update to my statement of registrable interests.

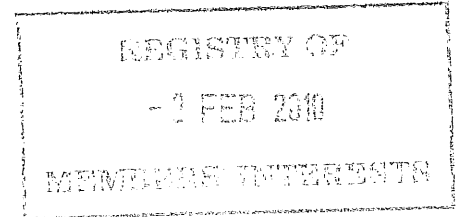

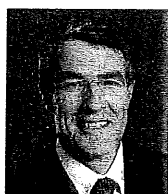

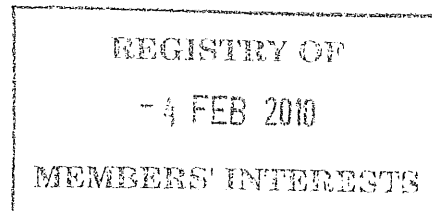
