During this visit, all meals, transport to and from the region Ex Perth together with accommodation on Wednesday 11 June 2008 were provided by the host organisations.



On neither occasion did I request, intimate or expect such favourable treatment. Whilst appreciated, both seating allocations amounted to an involuntary upgrade.




