

Upon my appointment as Parliamentary Secretary I immediately disposed of a number of IAG shares which I had acquired as a result of the demutualization of NRMA Insurance.

I have recently been advised, however, that I was automatically allocated an additional holding of IAG shares under the company's dividend reinvestment plan. This new issue comprises a total of 34 shares, with a valuation of \$124.44 as at 1 December 2008.

Since becoming aware of this situation I have been endeavouring to dispose of these residual shares as quickly as possible. The small number has made this difficult but I have now ascertained a means of disposing of them which will also enable me to offer the proceeds to charity. This process is underway and I will advise you as soon as I have concluded the transaction. IAG has indicated to me that once these shares are disposed of there will be no more reinvestment issues.
