

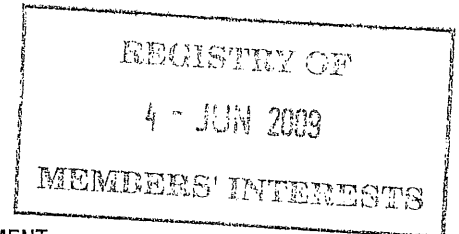

Dear Mr Wright,

I write to advise that between the 25 April and 5 May 2009 I travelled to Papua New Guinea with Jason Clare MP, Member for Blaxland, and a group of young people from our electorates to walk the Kokoda Trail.

The purpose of our trek was to build bridges between our two communities in the wake of the riots and revenge attacks in Southern Sydney in December 2005. The group included four young surf lifesavers from the surf clubs of Cronulla and four young Muslim Australians from the suburbs of Bankstown.

The trek was sponsored by companies, local clubs and individuals. These funds covered the cost of trekking fees and accommodation for the group. Jason and I paid for our own trekking and accommodation costs.

Qantas provided our group with 15 return airfares between Sydney and Port Moresby. I wish to declare that I was provided with one return flight to Port Moresby courtesy of Qantas.

The other purpose of the trek was to raise money for Sydney Legacy. After all expenses were paid we anticipate a donation will be made in excess of \$10,000 to Sydney Legacy.

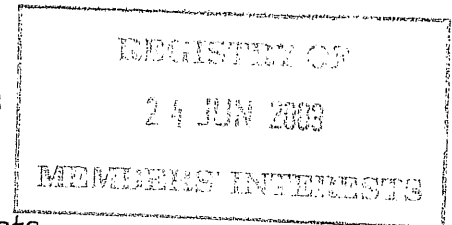
